At long last the assignment of courtrooms for newly elected judges and a change in courtroom for a sitting judge has been finalized. They are as follows:

Judge elect Julie Lynch will take office Jan. 3rd. Judge Lynch will be assigned to the docket that had been assigned to Judge McGrath (7C).

For the week of Jan. 3rd Judge Lynch will hear cases in courtroom 7C.

Commencing Jan. 10th Judge Lynch will move to courtroom 6B.

Judge elect Richard Frye will take office on Jan. 10th. Judge Frye will be assigned to the docket that had been assigned to now retired Judge Miller (6B). Judge Frye will be assigned to courtroom 8A.

Judge elect Michael Holbrook will take office Jan. 3rd. Judge Holbrook will be assigned to the docket of Judge Tommy Thompson (9A). Judge Holbrook will be assigned to courtroom 9A.

Judge John Bender will take office Jan. 10th. Judge Bender will retain the docket for courtroom 7B and will remain assigned to courtroom 7B.

Note: Judge Bender will be without office from Jan 1st to Jan. 9th.

Judge Alan Travis (8A) will maintain his current docket but will change his location to courtroom to 7C commencing Jan. 10th.

Judge elect Eric Brown will take office on July 1st and will be assigned to courtroom 5A. Courtroom 5A is to be constructed on the 5th floor of the Hall of Justice.
